### Plumber's Mate/Labourer UK-PHMES CSCS Registration Card (Green)

- i. A Green JIB-PMES CSCS Card is issued to Plumber's Mates/Labourer's who:
  - Pass the Level 1 Award in Health and Safety in a Construction Environment qualification (or equivalent qualification); and
  - Pass the CITB Health, Safety and Environment operative test
- ii. UK-PHMES CSCS Registration Cards issued on this basis are valid for up to five years, and may be renewed after that period (subject to renewal rules).
- ii. This route of entry is permanently open.
- iv. To obtain a Plumber's Mate/Labourer UK-PHMES CSCS Registration Card applicants must:
  - Correctly complete an application form and supply the appropriate fee
  - Pass the Level 1 Award in Health & Safety in a Construction Environment or an equivalent qualification (see list below)
  - Pass the CITB Health, Safety and Environment operative test.

#### IMPORTANT NOTE: SPECIFIC REQUIREMENTS FOR THE GREEN PLUMBER'S MATE/LABOURER CARD

Since March 2017 new green card applicants have been required to complete a **Level 1 Award in Health & Safety in a Construction Environment** qualification or an appropriate equivalent qualification. ### Note: NARIC equivalence reports

v. Those applying for cards by providing NARIC equivalence reports are also required to provide a copy of valid photographic identification (e.g. Biometric Residence Permit or Passport). This should be included at the time of application along with the NARIC equivalence report. Failure to submit a copy of valid photographic ID with the application form will result in the application being returned to the applicant.
