Guidance Notes

Site Visitor JIB-PMES CSCS Registration Card (Yellow)

- i. A Yellow JIB-PMES CSCS card is issued to site visitors who pass a General CSCS site safety test and who have confirmation from their employer of the occupation they are employed in.
- ii. JIB-PMES CSCS Registration cards issued on this basis are valid for up to five years, and may be renewed after that period (subject to renewal rules).
- iii. This route of entry is permanently open.
- iv. To obtain a Site Visitor JIB-PMES CSCS Registration card, applicants must provide the following:
 - A correctly complete application form and the appropriate fee.
 - Pass the CITB Health, Safety and Environment test.
