#### **Guidance Notes**

#### **JIB-PMES CSCS Registration Card for Experienced Workers**

- i. The Experienced Worker card is available for workers who meet the following criteria:
  - Those with at least 3 years' experience of working in the industry who are registered for an appropriate NVQ Diploma; NVQ/SVQ or acceptable Level 2 or 3 Diploma qualification (but who have not yet achieved) and are employed in the plumbing and mechanical engineering services industry.
  - Those with at least 3 years' experience of working in the industry who are in the process of enrolling/registering on an appropriate NVQ
    Diploma; NVQ/SVQ or acceptable Level 2 or 3 Diploma qualification and are employed in the plumbing and mechanical engineering
    services industry.
  - Acceptable qualifications for each occupational area include those listed below:
    - 1. Plumbing -
      - Level 2 NVQ Diploma in Plumbing and Heating (C&G 6189-11; BPEC or EAL equivalent qualifications)
      - Level 2 NVQ Diploma in the Installation and Maintenance of Plumbing and Heating Systems (LCL)
      - Level 3 Diploma in Plumbing and Domestic Heating (C&G 9189; BPEC or EAL equivalent qualifications)
      - Level 3 NVQ Diploma in Domestic Plumbing and Heating (C&G 6189- 31; BPEC or EAL equivalent qualifications)
      - Level 3 NVQ Diploma in Domestic Plumbing and Heating (Gas Fired Warm Air Appliances) (C&G 6189-32; BPEC or EAL
        equivalent qualifications)
      - Level 3 NVQ Diploma in Domestic Plumbing and Heating (Gas Fired Water and Central Heating Appliances) (C&G 6189-33; BPEC or EAL equivalent qualifications)
    - 2. Heating -
      - Level 2 NVQ Diploma in Domestic Heating (C&G 6189-21; BPEC or EAL equivalent qualifications)
      - Level 2 NVQ Diploma in Heating and Ventilating (C&G 6188-20/21 or 22)
      - Level 3 NVQ Diploma in Heating and Ventilating (C&G 6188-30/31 or 32)
    - 3. Gas Fitting -
      - Level 3 Diploma in Gas Utilisation (C&G 6014-03/04 or 55)
    - 4. Mechanical Pipefitting
      - Level 2 NVQ Diploma in Fabrication and Welding Engineering Pipework Fabrication (C&G 1782-20)
      - Level 2 NVQ Diploma in Heating and Ventilating (C&G 6188-20/21 or 22)
      - Level 2 Diploma in Supporting the Installation of Engineering Construction Plant and Systems Pipefitting (ECITB)
      - Level 3 NVQ Diploma in Fabrication and Welding Pipe and Tube Fabrication (C&G 1782-30)
      - Level 3 Diploma in Installing Engineering Construction Plant and Systems Pipefitting (ECITB)
      - Level 3 NVQ Diploma in Heating and Ventilating (C&G 6188-30/31 or 32)
- ii. It acts as an identification card during on-site training periods.
- iii. It shows that the cardholder is or is to be registered on an NVQ Diploma or NVQ/SVQ appropriate to his/her occupation, but has not yet completed.
- iv. Before an Experienced Worker card can be issued the applicant must provide the following:
  - Details of the course/qualification the learner is enrolled on, including course registration details

Or

- Confirmation of the Employer and applicant of the formal course/qualification the learner is enrolled on and commitment to provide appropriate registration details when available
- Confirmation of completing the appropriate health and safety units from the qualification

Or

- Confirmation of completing the CITB Health, Safety and Environment test for operatives.
- v. Work Experience cards are valid for up to three years.

Please note students registered on C&G 6035 (VRQ) technical certificate or other equivalent courses who are not continuing their training to obtain a full qualification are not eligible for this card.
